#### Successful PPP: Water Management with Saur Neptun Gdańsk (1)

- Saur Neptun Gdańsk (SNG) water management project has been identified as one of the best potential examples of projects with PPP characteristics in Poland.
- ■This is a 30-year contract for the operation and management of a water supply system signed by the City of Gdańsk with the French company Saur in 1993.
- It was established on the basis of the Municipal Services Act and the Property Management Act long before formal PPP legislation had been introduced.
- ■This arrangement involved both water supply and the collection and treatment of sewage for the neighbouring cities of Gdańsk and Sopot.
- ■Poor water quality, leaks, interruptions to supply and inadequately treated sewage had all been problematic while the public authorities did not have sufficient funds to rectify these issues.
- ■By 2007, there had been over 1,300 km of water supply network and almost 1,100 km of sewerage installed in both cities.

#### Successful PPP: Water Management with Saur Neptun Gdańsk (2)

- ■According to the contract, the operator has been obliged to provide permanent services of high quality and this requirement led to the modernisation of the infrastructure, still owned by the public authority.
- ■Between 1993 and 2005 SNG successfully implemented innovative solutions for both the organisation of the company and technological development.
- In 2005 the City Council of Gdańsk passed a resolution according to which, the new company Gdańska Infrastruktura Wodociągowo-Kanalizacyjna (GIWK-Waterworks Infrastructure of Gdańsk) became the owner of the infrastructure and this was accepted by the European Commission. (EU Grant),
- ■The implementation of the project in compliance with contractual requirements provided the citizens of Gdańsk and Sopot with high quality services.
- SNG was entitled a "good partner of local government" for its model cooperation with local authorities.
- ■The company also received an honour of being a patron of local sport.
